Sub – Engagement of retired personnel on short-term contract basis as Consultants in grade of **Group 'C'** in the O/o CCA, Gujarat Circle, Ahmedabad .


In pursuance of DOT HQ. Letter No.33-11/2011-SEA-III dated 27.02.2013 and DOT letter No-33-11/2011-SEA-III dated 15-06-2017 CCA,Gujarat Circle, Ahmedabad, proposes to fill up vacant posts in SA/JA/LDC on short term contract basis from among the retired personnel of Department of Telecommunication/Posts, other Organized Accounts Services of Govt. and BSNL/MTNL,as per the details given below under following terms and conditions-

- 1.The retired persons shall be appointed on short-term contact basis for a period of six months. Based on his/her performance and requirement of his/her services the contract can be further extended up to 70 years of age. The assessment of a head of CCA shall be final in this regard.
- 2.Candidate should not be more than 70 years as on 30-06-2019.
- 3.Computer literacy is a must.
- 4.The consolidated Fee/remuneration payable to retired person engaged on short Terms contract basis shall be restricted to the difference between last pay drawn(as per 7th CPC) by the retired official and basic pension + DA at the rate applicable for central Govt employees. The person so engaged shall not be eligible for other allowances and benefits. The payment will be made on monthly basis.
- 5.The Income Tax or any other Tax liable to be deducted as per the prevailing rules will be deducted at source before effecting the payment for which the Department will issue TDS certificate. Service Tax as applicable shall be payable extra at the prevailing rates.
6. The engagement of retired personnel on short term contract basis can be terminated by either of the party with prior notice of 30 days.
- 7. Eligible willing personnel may submit application on or before 28-06-2019.**
